

## **REACH Declaration**

The Registration, Evaluation, Authorization and Restriction of Chemical (REACH) is a European Community Regulation (EC 1907/2006) that requires to European Union (EU) manufacturers and importers to determine if they must register/notify certain Substances of VeryHigh Concern (SVHCs) to European Chemicals Agency (ECHA) or communicate to customers if any SVHC or preparations is present in articles or preparations they manufacture or import into the EU.

**Zennio Avance y Tecnología S.L.** (hereafter referred to as Zennio) develops, manufactures and sells electrical and electronic products whose components are classified as articles and it has undertaken to support the aim of REACH in improving the protection of human health and the environment.

With respect to the REACH Regulation, Zennio offers the following information regarding its products:

## Article 7 – Registration and Notification

Regarding Article 7(1) and 7(2) of the REACH Regulation, articles produced by Zennio do not contain neither substances intended to be released under normal or reasonably foreseeable conditions nor substances of Very High concern (SVHCs) that exceed 1 ton per year; hence **Zennio** is not required to register or notify ECHA under Article 7(1) and 7(2).

## <u>Article 33 – Communication of Substance Information</u>

Article 33 requires a supplier to inform customers when an article contains a substance(s) on the SVHC Candidate List in excess of 0.1% w/w.

Zennio, through auditing supplier material composition declarations and internal material review, to the best of its knowledge, has determined, that, **except for the SVHCs identified in** <u>Annex 1</u>, no other SVHCs are present in Zennio articles, products or packaging material in a concentration above 0.1% w/w.

## Substance Restrictions (Annex XVII) and Authorization List (Annex XIV)

Substances listed in Annex XVII and Annex XIV are restricted to be applied or require an authorization prior to use. Zennio has determined that neither restricted substances in Annex XVII nor substances subject to authorization in Annex XIV are included in Zennio products and packaging; hence, all our products are compliant with Annex XIV & XVII according to the REACH Regulation.

Zennio regularly monitor and assess changes in the SVHC candidate list and keep close contact with its suppliers to ensure compliance with REACH Regulation.
